

## TERMS AND CONDITIONS: BEACH TOWEL GIVEAWAY PROMOTION

**THE PROMOTION:** Get a free Fresh 'n Rebel 'Beach Towel' worth €34.99 when spending at least €50 on Fresh 'n Rebel products. The promotion is valid from 05-07-2021 until 31-08-2021, only while stock lasts.

Anyone who claims the promotion by agreeing to the Terms and Conditions is hereafter referred to as 'participant(s)'.

Participants can take part in the promotion by purchasing at least €50 worth of Fresh 'n Rebel products in total at one of the (online) stores in all participating countries (Netherlands, Germany, Poland, Italy, Belgium, France, Spain and Portugal) or at [www.freshnrebel.com](http://www.freshnrebel.com).

### HOW IT WORKS:

1. Participants are entitled to a free Fresh 'n Rebel Beach Towel when spending at least €50 on Fresh 'n Rebel products, both in physical shops and online stores.
  - a. When purchasing in a physical shop, participants can claim the Beach Towel by filling out the form at [www.freshnrebel.com/beachtowel](http://www.freshnrebel.com/beachtowel) which asks for name and address details to send the Beach Towel to. Also, participants must upload a copy of the proof of payment (receipt or invoice) to verify that at least €50 worth of Fresh 'n Rebel products is purchased.
  - b. When ordering online through a (r)etail partner, participants have to follow the same steps as described under section 1a.
  - c. When ordering online at [www.freshnrebel.com](http://www.freshnrebel.com), participants have to add the Beach Towel to their order themselves. When spending at least €50, the Beach Towel will be free of charge.
2. The free Beach Towel will be sent to the participant by Fresh 'n Rebel in case of a purchase at a (r)etail partner. In case of a purchase at [www.freshnrebel.com](http://www.freshnrebel.com), the Beach Towel will be sent along with the order, only when the Beach Towel is added to the basket by the participant manually.
  - a. When a participant places an order at [www.freshnrebel.com](http://www.freshnrebel.com) and does not add the Beach Towel to the order manually, it can still be claimed afterwards via the form at [www.freshnrebel.com/beachtowel](http://www.freshnrebel.com/beachtowel), as described under section 1a.

Shops follow the guidelines of the government regarding COVID-19.

**PARTICIPATION:** Participants are entitled to 1 free Beach Towel per order and this can't be exchanged for cash, change or products of similar value. Combining purchases/receipts where the total value exceeds €50 is not possible. A bank statement as a substitute for the purchase receipt is not valid.

When purchased through a (r)etail partner (both online and in physical shops), the free Beach Towel can be claimed until 31-10-2021 (11.59 pm).

The offer is not valid in combination with other promotions and is only valid while stocks last, from 05-07-2021 (12.01 am) to 31-08-2021 (11.59 pm).
